I was the second Questionnaire: I asked many questions regarding the reintroduction of site F to the draft Sheffield Local Plan. I also made my objections.

**Extracts from 11<sup>th</sup> January 2023 Meeting: "**(Michael Meredith) – So the inspector at the planning inspectorate, I suggested that Avant homes move its thing to Norton Aerodrome. Sheffield City Council's barrister said that he thought it was a good idea. I explained that there was already funding from the government for Owlthorpe from natural England for the Owlthorpe Heritage nature trail and also there is funding to redevelop the Norton Aerodrome. Sheffield City Council's barrister thought it was an extremely good idea."

I had a conversation with you after the meeting 11<sup>th</sup> January 2023. I explained that I had suggested to Planning Inspector O S Woodwards regarding moving the project from Owlthorpe to the Norton Acrodrome. I explained that the MOD may be responsible for removing asbestos from the site. Roland Bolton, Strategic Planning Research Unit, Mrs Stephens, Sheffield City Council and Mrs Hull, Sheffield City Council proclaimed that Norton Aerodrome is a greenfield site so Avant Home could not transfer to that site. I disagreed. Reported in Sheffield Star March 29 2021 "Demolition finally gets underway at former air base." Buildings have now been removed, so there was no reason why Avant Homes could not have removed their project to the Aerodrome at Norton. At the meeting you explained that Norton Aerodrome has now been introduced to the Sheffield Local Plan with a proposal to build 270 new properties. I believe that Norton Aerodrome is an excellent choice for building purposes.

### Please can you answer the following questions under the freedom of information act.

### The Questions have Health and Safety implications.

**Question 1:** There have been several sinkholes appearing in Sheffield. When engineers investigate, they state that the problem has occurred because of rotting pit props from old mine workings. I have asked the Coal Authority Question 3. Regarding flooding, what effect does flooding have on the timber props that hold the roofs up in old mine workings that run under Owlthorpe? Coal Authority answers "We do not hold information on timber props used in old mine workings or the effect that flooding may have on them." I understand that Sheffield (LPA) holds mining records of the mines that run under Owlthorpe. We understand that millions of coal were extracted from under Owlthorpe and delivered to the power station at Meadowhall. Residents of Owlthorpe have a right to know how safe the mines are that run underground. In the Reports from Lithos Consulting; Probe hole Log 18 Strata Wet between **14.2m and 18m, heavy water inflow** below 14.8 metres depth, much nearer the surface than 60 meters, reported by the Coal Authority. This problem may be caused because the land dips away from the header waters of the Ochre Dyke standing at 197.5 Metres above sea level. To Site C and D standing at 81 Metres above sea level a difference of 116 Metres. Pit head of Birly woods pit stands at 138 Metres above sea level, a difference of 57 Metres above sea level. Pit head of Moorhole Colliery stands at 116 Metres above sea level, a difference of 35 Metres. **Can you please make records of mine workings that run under Owlthorpe available on line so residents of Owlthorpe can see them?** 

# Question 2: Can you supply information on the state of pit props after being subject to water inflow on pit props in Owlthorpe?

**Question 3:** The Coal Authority and the Environment agency explain that Sheffield City Council are responsible for the Ochre that poured out of the disused mine working that runs under Owlthorpe as seen in this video. <u>https://www.ecological-owlthorpe.org/Ochredyke2.mp4</u> Ochre deposits were found on farm land from Beighton all the way down to Fishlake. **Question 3: What are the outcomes of Ochre on the food chain?** 

Question 4: In an Appeal Decision, Inquiry Held on 12-15, 19, and 21 January 2021 Site visit made on 20 January 2021 by O S Woodwards BA(Hons.) MA MRTPI an Inspector appointed by the Secretary of State Decision date: 2 March 2021 Quote: "MAIN ISSUES 7. The principle of development is not in dispute between the main parties. The site is one (Site E) of three sites (Sites C, D and E) in the Owlthorpe area which have been allocated for residential development for some time, as set out in Policy H13 of the Unitary Development Plan 1998 (the UDP), and in detail in the Housing Sites (C, D, E), Moorthorpe Way, Owlthorpe Planning and Design Brief, November 2017 (the Brief)." <u>owlthorpe.org/ecologicalserveys.html</u> provided by Derek Whiteley 2010,2011 and 2012. Records added to Sheffield Biological Records Centre RECORDER database. He said that they were out of date. Derek Whiteley thought that funds had dried up and so did we. But now we find out in **Roger Marsh's petition dated:** 5<sup>th</sup> October 2023 that Sheffield City Council deliberately stopped funding surveys because they wanted to develop plot C, D and **Extracts from Roger Marsh's petition**: "The agreement that we had with SCC was that we would be supported in this environmental work on the understanding that we would not carry out any work or object to the building of houses on Sites C, D, and E."

"SCC agreed to Celia Jackson's petition and accordingly removed Site F as housing land from the current Local Plan. Subsequently I lobbied SCC to get the release of outstanding Section 106 monies (retained by the builder of Woodland Heights housing development at Owlthorpe for 10 years). Once the £67,455 Section 106 monies had been released, we completed many planned environmental projects."

"Phase 2. We also carried out Dry Stone Wall Restoration Projects and Hedgerow Planting and Laying Projects. A large proportion of this work was paid for by grants from Sheffield South East Ward Pots."

At the planning inspector's enquiry Sheffield (LPA) were happy to put plot C, D and E up for sale. Question 4: Can you explain why Sheffield (LPA) has allowed the deforestation of Plot E and the building of new houses. Yet plot E had the same ecology value as plot C and D?

**Question 5:** Sheffield City Council put the plots of C, D and E up for sale. E has been developed. The planning inspector is expecting plot C and D to deliver 150 new properties. By removing plot C and D from the local plan has left a deficit in the local plan of 150 new homes. **Question 5: Has Sheffield (LPA) reintroduced plot F to save face with the Planning Inspectorate?** 

Question 6: Facts Mater, you say that "The Council's Ecology Unit has assessed Site F as part of the site selection process and it is very different in value to the 'Owlthorpe Fields' area (Sites C and D), which are to be protected in the Local Plan as a Local Wildlife Site and Local Green Space. The Plan includes conditions on the site allocation to protect the hedgerows and other ecologically valuable areas." The problem with your statement is that evidence supplied by Natural England under the freedom of information act shows that the hedgerows/ditches of very high environmental value are nowhere near site C or D. The orchard is also nowhere near plot C and D. Geography counts. https://www.ecological-owlthorpe.org/HigherLevelStwardshipAgreementMap.pdf Although Sheffield City Council has received funding for many years for the maintenance of Owlthorpe the area has been neglected, the wetlands opposite Edenthorpe are completely overgrown and the Hedgerows look more like poplar trees. After so many years of neglect last year, Sheffield Countryside Conservation Trust have hosted a class on orchard pruning, they also ran a class on Hedge Laying. I was invited to observe the Hedge Laying class. Theas are the GPS coordinates of the hedge laying 53.337349, -1.378872 if you type into any google map you can see exactly where they are. The Hedge Laying class took place on Phase one of the Grassland grazing project, not on-site C, or site D. I have never seen any Hedgerows on site C. Can you explain where they are. Question 6: Can you explain why you have removed site C and D and replaced them with site F without consultation with residents of Owlthorpe who know the geography of Owlthorpe, and are aware of the funding from both Sheffield City Council in the construction of our Oasis also the government funding support from Natural England for the maintenance?

Question 7: The document supplied by Howard Baxter Sheffield (LPA) to the inspectorate bears no resemblance to the content of the Planning and Highways Committee Meeting 2nd June 2020 I observed. I made complaints to the Planning inspector. Sheffield City Council Barrister Guy Williams investigated on my behalf and arranged with Lucy Bond, Area Team Manager (City Centre & East Team) Development Management City Growth Department, for me to review. The planning Solicitor, Kate, explained the procedure and vote was taken with many of the committee citing traffic impact as the reason for rejecting this application. The result was 10 against with 2 abstentions. After the vote was taken Colin Walker Interim Head said **"I think there is a significant risk if you throw Highways impact into this as a reason for refusal and that risk is that you effectively neutralise the site in residential terms." If Inspector O S Woodwards had reviewed the video footage I do not think building on plot E would have been granted? I have reported Inspector O S Woodwards to the Parliamentary Ombudsman for his conduct in the enquiry. Copies of the videos are available; would you like a copy? I believe Inspector O S Woodwards was derelict in his duties as an independent arbitrator. I have followed the Planning Inspectorate's procedures. Copies of the videos are available; would you like a copy? The Planning Inspectorate is aware of my ongoing complaint.**

**Question 7:** In the Draft Planning Design Brief for Housing Sites (C, D, E), Moorthorpe Way Owlthorpe Dated: 21 February and 7<sup>th</sup> March 2014 it states on page 42: "The Coal Authority is keen to ensure that coal resources are not sterilised by new development. Where this may be the case, the Coal Authority would seek prior extraction of the Coal, removing any potential land instability problems."

"If you wanted to cite more detail in the brief to help the implementation of the site you could add: Parts of site C, D and E are underlain by a coal outcrop which may have been worked in the past. A coal Mining Risk Assessment will need to be undertaken to assess the impact of mining legacy and determine what mitigation measures may need to be undertaken. Given the nature of the risks." **Question 7: Do you agree with me that Sheffield (LPA) should have made it more clear to Avant Homes and Inspector O S Woodwards that coal must be removed before building takes place?** 

### Question 8: Can you explain why this

In Inspector O S Woodwards Appeal Decision there is no mention about the fact that permission to remove surface coal must be obtained from the Coal Authority before construction can take place. **Please explain?**

**Question 12:** As a result of COVID many employees have been working from home. This works especially well for moms with young children, they can fit work around looking after their children. Many employers have realized that they no longer need expensive office space. Many companies are not renewing their leases on office space. **My Question is, can offices be converted into residential properties?** Empty offices do not generate revenue for Sheffield City Council.

Question 13: With the expansion of on-line selling, many retail outlets are redundant. My Question, can retail outlets be turned into residential? Empty retail outlets do not generate revenue for Sheffield City Council.

Question 14: When students leave University, they explain that they would prefer to rent and live in the City Centre not the suburbs. My Question, should Sheffield (LPA) build more new houses in the city centre or continue to destroy the suburbs?
